1. STUDENT SELECTION

All the online admission process is handled by Directorate of Technical Education, Maharashtra, Admission Regulating authority, Mumbai and State Common Entrance Test Cell, Mumbai including conduction of the Maharashtra State Common Entrance Test (MHT CET) for Engineering and Technology admission, declaration of CET result, online registration for admission process, document verification, preparation of the merit list, conduction of CAP round, allotment of seats as well as confirmation of admission and commencement of classes.

Directorate of Technical Education (DTE), is working as governing authority of Government of Maharashtra, announces Engineering and Technology admission process by publishing notification on their website (www.dtemaharashtra.gov.in) and in different leading Newspapers.

Also, college participates in educational fairs organized by different agencies to provide necessary information regarding institute coursers and intake capacity, admission programmes, changes in admission process, government scholarships and documents required for such admissions through the institute prospectus and power point presentation to aspirant students.


DTE, Mumbai, works as a governing authority of Centralized Admission Process (CAP) of Engineering and Technology admission. The notification regarding admission process and important dates of various stages of admission are announced by DTE and published on their website as well as in leading newspapers.

For first year engineering and Direct Second Year Engineering institute participates in Centralized Admission Process undertaken by DTE, Maharashtra.

2. CENTRALISED ADMISSION PROCESS FLOW

The Government of Maharashtra strictly regulates the admissions to First Year Engineering Under Graduate Courses and the rules and regulations are same for all the institutions. Around 80 percent seats are allotted based on the marks obtained by the candidate in Common Entrance Test (CET) conducted by Directorate of Technical Education (DTE) and the reservation seats are allocated as per the proper documentation submitted to the CET Portal related to the reservation category. This is later verified by the Maharashtra Direct Benefit Transfer Scholarship (MAHA DBT). Remaining 20 percent seats may be allotted by the Institute and are called as Institute Level Admissions or SPOT admissions.

After the students are allotted to our college, the admission team follows the below process and helps the students to get enrolled into the undergraduate course.



3. ELIGIBILITY CRITERIA

Maharashtra State Candidature Candidate

- The Candidate should be an Indian National
- Passed HSC or its equivalent examination with Physics and Mathematics as compulsory subjects along with one of the Chemistry or Biotechnology or Biology or Technical or Vocational subjects, and obtained at least 50% marks (at least 45% marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only) in the above subjects taken together; and Obtained score in MHT-CET.
- Passed Diploma in Engineering and Technology and obtained at least 50 % marks (at least 45 % marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only)
- Passed B.Sc. Degree from a Recognised University as defined by UGC. and obtained at least 50 % marks (at least 45% marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only) and passed XII standard with Mathematics as a subject.

All India Candidature Candidates, Jammu and Kashmir Migrant Candidature Candidates

- The Candidate should be an Indian National
- Passed HSC or its equivalent examination with Physics and Mathematics as compulsory subjects along with one of the Chemistry or Biotechnology or Biology or Technical or Vocational subjects and obtained at least 50% marks (at least 45% marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only) in the above subjects taken together and Obtained score in JEE(Main) B.E./B.Tech or MHT-CET.
- Passed Diploma in Engineering and Technology and obtained at least 50 % marks (at least 45 % marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only)
- Passed B.Sc. Degree from a Recognized University as defined by University Grants Commission and obtained at least 50 % marks (at least 45 % marks, in case of Backward class categories and Persons with Disability candidates belonging to Maharashtra State only) and passed XII standard With Mathematics as a subject

- 3. One percent (1%) seats of CAP Seats (excluding Minority institutions, All India Seats, ifany) shall be reserved for Orphan Candidates.


7. INSTITUTE LEVEL ADMISSIONS AND VACANT SEATS AFTER CAP

The Principal of the institution shall carry out the admissions for these seats in the following manner:

- These admissions should be carried out strictly based on inter se merit of theCandidates who have applied for Institute Level Quota admission.
- Information brochure of the institution which specifies rules of admission should be published well before the commencement of the process of admission. All the information in the brochures should also be displayed of the Institution's notice board and website.
- Institution shall invite applications by notifying schedule of admission and the number of seats in each course to be filled by the institution, by advertisement in at least two leading newspapers and on website of the institution.
- Aspiring candidates fulfilling the eligibility criteria as notified by the Government and specified by the appropriate authority, from time to time, shall apply to the Principal of the respective institution for admission at the Institution level
- The institution may give admission to the applicants based on their inter-semerit derived from Merit list declared by the competent Authority for filling the seats in the Institutional Quota as well as Vacant seats after CAP Admission.

8. DYPCOEI ADMISSION PROCESS

The admission process flow shown below is the process through which the candidate gets admitted at the institute and needs to follow all the desks right from desk 0 to desk 9 to complete the admission process using the ERP system.



The above flowchart is followed by all candidates who wish to continue their journey of engineering at our campus. The admission team takes active efforts to channelize the admission process smoothly using proper ERP system.
